

In Memoriam—Wendell Schick

It is with a heavy heart that we share the passing of **Wendell Schick** in October 2022. Wendell retired from the University of Northwestern Ohio in 2021.



Wendell spent 38 years of his life working in the financial aid arena, 18 of which spent at UNOH. He served OASFAA in multiple committee positions and was elected president for the 2003-2004 year. He also volunteered his time and was appointed to various positions within the following organizations: Student Access and Success Coordinating Council of Ohio, Student Portal Web Development Committee of Ohio, Ohio Board of Regents Advisory Group, Great Lakes Higher Education Advisory Group, Ohio Student Loan Commission Advisory Council, Regional Chair of the Ohio Student Aid Commission, Ohio Foundation of Independent Colleges Advisory Group, National Advisory Board of the Sallie Mae Loan Program, National Advisory Group of the Law Access Loan Program, the College Board, and the Lima Access Group. Prior to his time at UNOH, he worked in financial aid at Ohio Northern University for 20 years. Wendell made an impact on the financial aid operations of UNOH that will last for many years to come, and his staff noted that they "could never thank him enough for his service to the University."



Micky M. Sharma, Psy.D.



Dr. Sharma is the Director of the Counseling and Consultation Service at The Ohio State University where he specializes in the treatment of mental health issues of college and university students. Dr. Sharma has also spoken professionally regarding the mental health needs of students and assisting a community through trauma at several conferences and forums. His career has spanned service in seven university counseling centers where he has worked as a clinician as well as an operations and training administrator.

Dr. Sharma has served as President of the Association for University and College Counseling Center Directors (AUCCCD). In addition, Dr. Sharma has previously served as a Board member for the Association of Counseling Center Training Agencies (ACCTA) and in the Council Position of the Disaster Response Network for the Illinois Psychological Association. His special areas of interest include: trauma, multiculturalism and diversity, professional consultation and collaboration, eating disorders, training and supervision. Dr. Sharma obtained his doctorate from the Illinois School of Professional Psychology/ Chicago Campus and in 2008 he received the Distinguished Alumni award from the institution.

Karen McCarthy

Karen is the Vice President of Public Policy and Federal Relations at NASFAA, playing a key role in the development and implementation of NASFAA's strategic advocacy goals and objectives. She began her career in student aid working in the financial aid offices at several large, 4-year institutions, including Boston University, Miami University of Ohio, and The Ohio State University. Ohio University conducted a Security Assessment using the NIST 800-171 framework to evaluate the institutional adherence to GLBA. 

Federal student loan borrowers are to begin re-entering repayment on their federal student loans by May 2023. 




